



**NOTICE OF PUBLIC MEETING
COMMUNITY DEVELOPMENT BLOCK GRANT INPUT HEARINGS AND FIVE YEAR
INFRASTRUCTURE CAPITAL IMPROVEMENT PLAN UPDATE
SAN JUAN COUNTY**

NOTICE IS HEREBY GIVEN that San Juan County will hold three public meetings for the purpose of receiving public input on the County's five-year Infrastructure Capital Improvement Plan (ICIP) and to receive public input on community development needs and suggestions for future Community Developing Block Grant (CDBG) projects.

The CDBG program was established under Title I of the Housing and Community Development Act of 1974, as amended, in order to assist communities in providing essential community facilities, providing decent housing for residents, promoting economic development and maintaining a suitable living environment.

State and national objectives of the CDBG Program require that assistance be made available for activities that address at least one of the following:

- An activity identified as principally benefitting persons of low and moderate income;
- Aid in the prevention and elimination of slums and blight;
- Meet other community development needs of recent origin having a particular urgency because existing conditions pose a serious and immediate threat to the health and welfare of the community where other financial resources are not available to meet such needs.

Applications are limited to a maximum of \$750,000, except for planning application which have a limit of \$50,000. Eligible activities and categories will be described. All interested parties are invited to attend, to submit project ideas, to provide supporting data and testimony, and other pertinent information.
